### **UNDERTAKING BY THE AUTHOR(S)**

The authors should provide a written undertaking signed by the senior author / authors that article submitted has neither been published elsewhere nor sent for publication at the time of submission.

### **COPYRIGHT / DISCLAIMER**

The Editorial Board reserves the right to modify articles so as to conform to the Journal style and standard. The views expressed in the articles will however, remain the opinion of the authors and the Editorial Board accepts no responsibility. JIMSA assumes no liability or responsibility for the accuracy, completeness and usefulness of the information contained in the published articles.

### **MANUSCRIPT SUBMISSION**

The manuscript of the article should be submitted in triplicate, typed in double space on standard A-4 size with 3 cm margin all around and should be sent to the **Editor JIMSA, 2<sup>nd</sup> Floor, National Medical Library Building, Ansari Nagar, Ring Road, New Delhi -110029 India**. Update/Review article, Original article should not exceed 10-12 typewritten pages; case report, brief communication, procedure, current drug therapy-6 pages. The article should be preceded by an **abstract** not exceeding 350 words; keywords, where ever relevant, should be given below the abstract. The original manuscript should be arranged in the following sequence: title page with address for correspondence, abstract, introduction, material and methods, results (or case report) discussion, table, legends to figures.

*CD with complete write up as given above including figures and legends, must accompany the article.*

### **References**

Number should not exceed 25 for update/review, 15 for original article, 8 for brief communication, case report, procedure and current drug therapy and 3 for letter to the editor (correspondence), the names of all the authors

should be mentioned up to three; if more than three, the first three names should be mentioned, followed by et al. The style of reference should be as follows: Mathur SM, Bhaskar K, Patel BD, et al. J Bronchoalveolar lavage, J. Assoc. Physicians India 1984,32:974-984.

### **Chapter from a book**

Fulphus SW, characterization, isolation and purifications at chollnergicreceptors in motor Innervations of muscle: edited by Sloff S, Academic Press London 1976; page 1-26.

**Tables**, if any should be at the end of manuscript.

### **Illustrations**

These should be on glossy paper and submitted in triplicate. The figure number, article title and top of illustration should be indicated on the back of photograph along with details of the individual illustration.

### **Letter to Editor**

Letter to the editor may comment on articles published in the journal or may provide original data or information. Letters commenting an article should be received within six weeks of publication, such letters will be forwarded to the senior author of the article, reply is expected within six weeks. In the absence of the reply, the letter will be published with a note standing.
