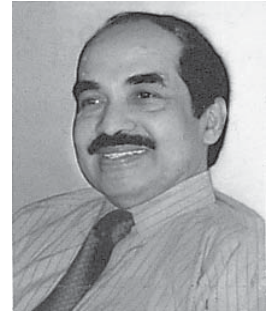
PRESIDENT WRITES
